

## BRITISH COUNCIL IELTS AWARD 2022 TERMS & CONDITIONS

1. Employees of the British Council along with their relatives (up to second degree of kinship) are excluded from the British Council IELTS Award 2022 programme.

2. Individuals wishing to apply for the British Council IELTS Award 2022 will need to ensure that they have their own access to the Internet. The British Council is not responsible for assisting with access to websites or for providing other technical assistance to any applicant.

3. Applicants bear full responsibility for the complete and correct filling in, and submission of, their personal information.

4. The decision of the awarding panel is final and no correspondence will be entered into.

5. The British Council IELTS Award 2022 is non-transferable and cannot be used by any person other than the successful candidate.

6. The British Council IELTS Award 2022, up to a maximum of £10,000, will be paid directly to the Higher Education Institution that the successful candidate will attend to cover the fees of the programme of choice, subject to the British Council officially confirming his/her application status with the institution. The tuition fees of the programme of choice must be a minimum of £3,000. The British Council IELTS Award 2022 will be paid at the equivalent of any other currency to be converted at the parity of the relevant currencies at the date of disbursement.

7. The British Council will not bear any responsibility for the loss of the British Council IELTS Award 2022, should the organisation be unable to notify the successful candidate, due to any issues connected to his/her e-mail, including, but not limited to, technical issues.

8. If tuition fees of the successful candidate are below the maximum individual award fund of £10,000, the remaining fund may be allocated to support other runners-up.

9. The British Council reserves the right to withdraw the British Council IELTS Award 2022 at its discretion, should the successful candidate not respond to the British Council, including failure to provide the British Council with any required information and documentation by 31 July 2022. After the aforementioned deadline the responsibility of the British Council ceases.

10. By submitting an application for the British Council IELTS Award 2022, applicants hereby consent to the publication of their names on British Council websites, if they are shortlisted.

11. Commitment: If you receive the British Council IELTS Award 2022, in order to support communication activities for the purpose of the Award:

- a) you agree to the British Council photographing and/or recording you and you give permission to the British Council to use without receiving any remuneration or indemnity any material in the photographs and/or recordings where the copyright or any other rights are owned by you;
- b) you confirm that the British Council shall be entitled to use, free of charge, the photographs and/or recordings made of you (without having to identify you by name), in their original format or edited, adapted or altered, for the purposes of the British Council's internal and external promotional and publicity materials and for any programmes, publications, websites, electronic publications and social media services worldwide produced by or on behalf of the British Council;
- c) you agree that the British Council shall be entitled to pass the photographs and/or recordings of you, and your name, to external press and media agencies, publishers, broadcasters and within the British Council network for the purpose of the British Council-IELTS Award 2022.

12. Entry clearance: If for any reason you cannot obtain a visa to study in the desired country of study, the British Council may withdraw the offer of the award.

13. Privacy notice: The British Council will use the information that you are providing in connection with your application for the British Council IELTS Award 2022 in Germany. The legal basis for processing your information is agreement with our terms and conditions of application (contract) which also include using the services of Eventsforce, London, UK, to capture and process your data online.

You authorise us to pass your information and monetary prize to the Higher Educational Institution of your choice.

14. Data Protection: The British Council complies with data protection law in the UK and laws in other countries that meet internationally accepted standards.

You have the right to ask for a copy of the information we hold on you, and the right to ask us to correct any inaccuracies in that information. If you have concerns about how we have used your personal information, you also have the right to complain to a privacy regulator.

15. Participation in the British Council IELTS Award 2022 programme presupposes and entails unreserved acceptance of all the terms and conditions

16. The information you submit will be used to consider your eligibility and suitability for the British Council IELTS Award 2022 and to manage the application process and for forwarding the prize to your Higher Educational Institution or to the winner candidate.

17. Documentation can be written in English and German. In cases where issues of the interpretation of the terms arise, the English version of the text supersedes all others.
